**Part 8 Public Notice Pursuant to the Planning and Development**  
**Regulations 2001 (Article 81) as amended**

Notice is hereby given that Leitrim County Council proposes to carry out the following works at Mullyaster, Newtowngore, Co. Leitrim:

Construction of 7 no. residential units which comprises of (a) Type A- 2 no. two storey 3 bed semi-detached houses (b.) Type B - 3 no. two storey 3 bed terraced houses. (c.) Type C – 2 no. single storey 2 bed semidetached houses.; and connections to existing public watermain, sewer and surface water drainage services and all ancillary and associated site development works.

Plans and Full Particulars of the proposed development are available for inspection, or purchase at a fee not exceeding the reasonable cost of making a copy, from **Wednesday the 28<sup>th</sup> of February 2024 to Monday the 1<sup>st</sup> of April 2024 inclusive**, during public opening hours, at the offices of the Planning Authority, County Offices, Carrick-on-Shannon, Co. Leitrim. Any person may, within 4 weeks from the date of this notice apply to An Bord Pleanála for a screening determination as to whether the development would be likely to have significant effects on the environment.
