

PECENTED. ISTOR ROR Comment: There is 200mm water main and three crossings running through the site as well as a 300mm foul sewer. Uisce Éireann has the following observations in respect of the proposed development: 1) Prior to the commencement of any construction works the applicant is to locate and protect all Uisce Éireann services and connections to same within the red-line site boundary. The applicant is to note that in accordance with the requirements of section 104 of the 2007 Water Services Act there shall be no building over water mains, common pipes, or sewers, and if found the applicant must contact Uisce Éireann with a proposal for altering at the cost of the applicant. 2) The integrity, operation and access to the sewer and watermain networks shall not be compromised by the proposed development works.

3) The proposed development works involved shall not adversely affect the operation of the sewer and watermain networks for the neighbouring properties.

4) Any works to either the watermain or sewer networks to be in accordance with Irish Water's Technical Documentation; 'Code of Practice's', 'Water Infrastructure Standard Details', and 'Wastewater Infrastructure Standard Details'.
