## **Leitrim County Council Environmental Impact Assessment (EIA) Screening Determination under the Planning and Development Regulations (2001), as amended, for the Proposed Greyway Development in the townlands of Drumod More, Dromod and Killinaker, Rooskey, Co. Leitrim.**

The Capital Projects Section of Leitrim County Council are proposing the construction of a 'greyway' development comprising of (1.) the construction of a 2m wide footpath for pedestrians with a 1m separation zone from the L1601 road carriageway, with the bridge crossing at Killinaker Bridge where the path will reduce in width to 1.5m and the separation zone to 0.6m; and (2.) the provision of drainage, fencing, landscaping and other ancillary works in the townlands of Drumod More, Dromod and Killinaker, Rooskey, Co. Leitrim. Leitrim County Council, in accordance with the requirements of EIA Directive (Directive 2011/92/EU as amended by 2014/52/EU; the Planning and Development Act 2000, as amended; the Planning and Development Regulations 2001, as amended; and the European Union (Planning and Development) (Environmental Impact Assessment) Regulations 2018, has undertaken an Environmental Impact Assessment Screening in respect of the proposed development.

Having regard to:

- a) The prescribed mandatory developments requiring EIA set out in Section 50 of the Roads Act 1993, as amended,
- b) the requirements of Article 81A(5) of the Planning and Development Regulations 2001, as amended,
- c) the nature and scale of the proposed development with regard to the thresholds of classes of development specified in Part 2 of the Fifth Schedule of the Planning and Development Regulations 2001, as amended,
- d) the criteria set out in Schedule 7 and 7A of the Planning and Development Regulations 2001, as amended,
- e) the guidance set out in the EIA Guidance for Consent Authorities regarding Subthreshold Development issued by the Department of the Environment, Heritage and Local Government (August 2003) and the other relevant Guidelines relied on in the preparation of the EIA Screening Report,
- f) the report and recommendation prepared by Liam Flynn, Acting Senior Executive Planner, informed by the Environmental Impact Assessment Screening Report prepared by JKW Environmental Ltd., that the proposed development would not be likely to have a significant effect on the receiving environment either directly, indirectly or cumulatively with other developments in the area.

Leitrim County Council has determined that the proposed residential development would not be likely to have any significant effects on the environment and, accordingly, that the preparation and submission of an Environmental Impact Assessment Report is not required.
