## SITE NOTICE

Pursuant to the requirements of Article 81 of Part 8 of the Planning Development Regulations 2001 (as amended) notice is hereby given that Tipperary County Council proposes to carry out the following development:

Location: Garraun, Golden, Cashel, Co. Tipperary

Description:

The development consists of an extension to the existing 3-bedroom single storey dwelling to form a new 6-Bedroom single storey dwelling including internal refurbishment of the existing dwelling on a total site of 0.183 Ha. at Garraun, Golden, Cashel, Co. Tipperary

Nature and extent of the proposed development is as follows:

The construction of an new extension to the existing 3-bedroom single storey dwelling to form a new 6-Bedroom single storey dwelling including new kitchen, living room, utility room, wet room, entrance hall and storage with revised bedroom layout and new footpaths / yards, underground services, treatment works, landscaping and all associated site works.

The development has been the subject of an **Appropriate Assessment (AA) Screening** in accordance with Article 6(3) of the EU Habitats Directive (Directive 92/43/EEC) and article 250(1) of the Planning and Development Regulations 2001 as amended. The Appropriate Assessment screening concluded that the proposed development would not be likely to give rise to significant or indeterminate impacts on any Natura 2000 site.

In accordance with article 120(1)(a) of the Planning and Development Regulations 2001, as amended, the proposed development has been screened to determine whether an **Environmental Impact Assessment (EIA)** is required and it has been concluded that from the nature, size and location of the proposal, there will be no real likelihood of significant effects on the environment arising from the proposed development and that an **EIA** is not required.
